Ministerial Order No: 16/2021 A.D for the mandatory requirement of Certificate of conformity to standards certificate for clearance of imported goods at all the entry points of South Sudan.

1. Title and Commencement

This Ministerial order shall be cited as" Ministerial order No: **16/2021 AD** for the mandatory of certificate of conformity to standards (COC) for imported general goods

2. Purpose and Objectives

The Purpose of this ministerial order is ensure that all imported products into the Republic of South Sudan meet the requirements of Standards and technical regulations set by the National Bureau of Standards in order to substantially reduces hazardous and sub standards imported products into the country, and to ensure that goods being sold are safe and not harmful to consumer health, protection of the consumer from adulterated goods or goods of doubtful origins and to guarantee reliability of weights and measures as well as trade description for goods and services, with the ultimate objection of that consumer is sincerely protected under any other conceivable circumstances

3. The Order

In exercise of the powers conferred upon me under article 114(1) of the transitional constitution of the Republic of South Sudan (2011), as amended 2015, read together with chapter two (2) section eight(8) article one(1) e, of the National Bureau of Standards act (2012), and the weights and measures act (2012), **I, Hon: Kuol Athian Mawien**, Minister of Trade and Industry, Republic of South Sudan, do hereby issue this ministerial order No: 16/2021. AD as follows,


- a) All imported general goods to the Republic of South Sudan must attached with the following documents, Certificate of Origin, Certificate of Analysis(test result) after physical inspection, and other relevant documents from regulatory authorities of the Republic of South Sudan
- b) All Imported general goods with mandatory standards to the Republic of South Sudan **Must have and accompanied with Certificate of conformity to Standards (COC)** from the country of origin (country of export) from authorized/ appointed International PVOC services providers.

Certification Crop.

- d) **A penalty of 15%** CIF value of the cargo will be charged at all entry points (Nimule, Nesitu and other border posts, Juba International airport) for imports without COC.
- e) Repeating importation of products without COC will let to the withdrawal of import license and further legal action provided in the National Bureau of Standards act (2012).
- f) Exemption products from COC are Cargo value under **\$2000 USD**, Diplomatic cargo, and any classified products determined by SSNBS.
- g) All government regulatory authorities, National Revenue authority, Ministry of trade and industry, National Bureau of Standards, and law enforcement agencies, are hereby directed to implement this ministerial order with immediate effect.

IMPLEMENTATION OF CONSIGNMENT BASED CONFORMAITY ASSESSMENT
(CBCA) PROGRAMME**

The Government of the Republic of South Sudan and Ministry of Trade & Industry would like to inform the general public and business community in particular that a Programme to have Consignments Verified in the Country of Export has been put in place. The CBCA (Consignment Based Conformity Assessment) Programme is intended to substantially reduce hazardous and substandard imported products in the country.

Within this CBCA Programme, conformity to standards of all goods intended to be exported to the Republic of South Sudan will be verified prior shipment in the country of export. Upon satisfactory verification, a Certificate of Conformity (CoC) will be issued for the consignment. This certificate shall be presented for customs clearance on arrival at all entry points in the Republic of South Sudan.

To implement CBCA Programme, the South Sudan National Bureau of Standards has signed a contract with Turkish Corporation namely ALBERK QA INTERNATIONAL TECHNICAL CONTROL AND CERTIFICATION CROP. Istanbul. All requests for verification of the products shall be made directly to ALBERK QA INTERNATIONAL TECHNICAL CONTROL AND CERTIFICATION CROP in Istanbul at international@gatechnic.com and their representative offices located worldwide.
