1. General

Authority:	Saudi Standards, Metrology and Quality Organization (SASO)
Regulations:	<p>SASO has introduced a new scheme known as SASO IECEE Recognition Certificate for certain electrical products.</p> <p>The new SASO IECEE Recognition Certificate is the recently introduced Saudi National Conformity Certificate issued based on a valid CB Test Certificate and CB Test Report.</p> <p>It guarantees that certified appliances are compliant with the standards of the IEC Conformity Assessment Schemes for Electrotechnical Equipment and Components (IECEE) while also taking into consideration the Saudi National Differences.</p> <p>The announcement of the SASO Recognition Certificate (RC) requirement was made effective from 15th February 2018. Hence all products under the scope of the SASO recognition scheme shall comply with the requirements to obtain the SASO Recognition Certificate.</p> <p>Upon arrival of the shipment containing the products and the corresponding HS codes in the scope of the SASO IECEE RC, the KSA Customs/Authorities will verify the availability of the Recognition Certificate from SASO.</p>

- Online application submission to SASO for a specific model that fulfills the required information online. The Applicant verifies that all of the information provided is valid.
- A Valid IECEE Test Report issued by a CB Testing Laboratory (CBTL)
- a valid CB Test Certificate issued by a National Certification Body (NCB)
- National Difference Test Report (if any)
- Manufacturer/ Importer Declaration of Conformity (DOC) (attached)
- Instruction User Manual (Arabic)
- Detailed product images
- Product Dimensions or Design
- Manufacturer /Importer Commercial Registry Certificate
- Trademark registration certificate / License
- Test Report for the Power Plug/Cord (if provided)
- If there is a charger available with the product, the below is also required:
 - IECEE CB Test Report for the Charger
 - IECEE Certificate for the Charger
 - Detailed product images

4. How to Apply for an IECEE Recognition Certificate?

Applicants can obtain SASO IECEE Recognition Certificate by applying through SASO's JEEM website, <https://jeem1.saso.gov.sa/>.

QA TECHNIC can apply instead of the client as well.

5. Certificate Validity

The SASO IECEE RC is limited to the scope indicated in it, and may not be used for any other purpose. The validity of the certificate is one calendar year from the date of certificate issuance. The holder of the certificate must apply for renewal at least 60 days prior to the certificate expiry date, or the application will be considered as new.
