- Trademark registration certificate / License
- Quality Management Certificates if available
- Efficiency labels for the related Products
- Gulf Mark Certificates for related Products

### 5. Certificate Validity

The Quality Mark Certificate is limited to the scope indicated in it, and may not be used for any other purpose. The validity of the certificate is three calendar years from the date of certificate issuance. The holder of the certificate must apply for a yearly renewal at least 60 days prior to the certificate expiry date, or the application will be considered as new.
