Authority:	Saudi Standards, Metrology and Quality Organization (SASO)
Regulations:	In March 2018, SASO has announced new Energy Efficiency Label regulations.
	These regulations are designed to ensure that the energy consumption efficiency for each product is documented. This helps Saudi Arabian consumers choose the most efficient product.
	Household appliances manufactured for sale in Saudi Arabia have to follow specific regulations related to energy efficiency. Electrical home appliances, such as refrigerators, air conditioners, washing machines, electric motors and lamps, require energy efficiency approval in order to successfully clear shipment from customs.
	As well as compliance to SASO standards for Energy Efficiency Labelling; the electrical goods under this program must also meet the minimum star rating, detailed inside each standard / specification in the table below

### 5. Certificate Validity

The Water Consumption Rationalization Certificate is limited to the scope indicated in it, and may not be used for any other purpose. The validity of the certificate is one calendar year from the date of certificate issuance. The holder of the certificate must apply for the renewal at least 60 days prior to the certificate expiry date, or the application will be considered as new.
