Ministerial Order No. 21/2022 A.D for mandatory implementation of Certificate of Conformity

1. Title and commencement:

This Order shall be cited as a Ministerial Order No. 21/2022 A.D for the mandatory implementation of Certificate of Conformity and shall come in to force on the date of its signature by the Minister:

2. Purpose:

The purpose of this Ministerial order is to Order all head of Stations to mandatorily start implementing Certificate of Conformity

3. Order:

In exercise of the power conferred upon me, under article 114 (1) of the Transitional Constitution of The Republic of South Sudan 2011 as amended 2015, read together with article 8 of Import and Export Act 2012. **I Hon. Kuol Athian Mawien**, Minister of Trade and Industry of Republic of South Sudan, hereby issue this Ministerial Order Number 21/2022 A. D as follow:

Order all Head of stations to immediately start implementing Certificate of Conformity.

This Order further directs all trade officers deployed at various checkpoints all over South Sudan, Security organs, National Economic intelligence officers, Customs officers, and anti-smuggling units in the Ministry of Interior to ensure that this order is implemented across South Sudan.

Importers and Exporter of goods **Must** show Certificate of Conformity alongside with Import and Export licensing upon arrival at the station before any clearance of goods.

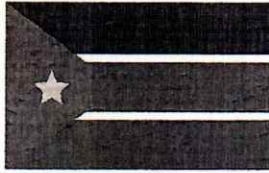
